### **Sensitization:**

Skin sensitizing effects were not observed in animal studies.

### **Signs and symptoms of overexposure:**

The substance / product is an anticoagulant rodenticide with a coumarin-type mode of action. If swallowed, this material may reduce the clotting ability of the blood and cause bleeding. The anticoagulants interfere with blood clotting and death results from hemorrhage. Exposed individuals become progressively weaker and lethargic due to blood loss.

### **Potential environmental effects**

#### **Aquatic toxicity:**

Very toxic (acute effect) to aquatic organisms.

## 4. First-Aid Measures

### **General advice:**

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. If person is not breathing, call 911 or ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or physician for treatment advice. Have the product container or label with you when calling a poison control center or doctor or going for treatment.

### **If inhaled:**

Remove the affected individual into fresh air and keep the person calm.

### **If on skin:**

Rinse skin immediately with plenty of water for 15 - 20 minutes.

### **If in eyes:**

Hold eyes open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing.

### **If swallowed:**

Never induce vomiting or give anything by mouth if the victim is unconscious or having convulsions. Do not induce vomiting. Have person sip a glass of water if able to swallow.

### **Note to physician**

#### **Antidote:**

For humans or dogs that have ingested this product and/or have obvious poisoning symptoms (bleeding or prolonged prothrombin times), Vitamin K given by injection is the antidote. Consult a Poison Control Center for guidance of when this treatment is indicated, monitoring for benefit, and how often to administer the agent.

#### **Treatment:**

The prothrombin time (PT) indicates whether an increased bleeding tendency is related to clotting factor deficiency and should be checked initially at 24 hours, and at 48 hours after exposure. For Dogs: Check prothrombin times every 3 days until values return to normal (up to 30 days). Blood transfusions may be needed.

### 5. Fire-Fighting Measures

### 6. Accidental release measures

**Environmental precautions:**

Do not discharge into the subsoil/soil. Do not discharge into drains/surface waters/groundwater. Contain contaminated water/firefighting water.

**Cleanup:**

Dike spillage. Sweep/shovel up. Avoid raising dust. Use wet cleaning methods when applicable. Place into suitable containers for reuse or disposal in a licensed facility. Spilled substance/product should be recovered and applied according to label rates whenever possible. If application of spilled substance/product is not possible, then spills should be contained, solidified, and placed in suitable containers for disposal. After decontamination, spill area can be washed with water. Collect wash water for approved disposal.

### 7. Handling and Storage

**Handling**

**General advice:**

### Storage

#### **General advice:**

#### **Hand protection:**

Safety glasses with side-shields. Tightly fitting safety goggles (chemical goggles). Wear face shield if splashing hazard exists.
